



**PUBLIC NOTICE**  
**FOR EXPRESSION OF INTEREST**

**SUBJECT: Direct award procedure pursuant to Article 1, paragraph 2, letter a) of Law 120/2020, for the selection of the contractor to be awarded the service of simultaneous translation, consecutive translation and translation of documents for the activities of IPA Floods and Fires programme in Bosnia and Herzegovina.**

This market survey is launched in order to identify, in compliance with the principles of free competition, equal treatment, non-discrimination and transparency, economic operators interested in participating in this procedure.

**SUBJECT OF THE CONTRACT:**

**Service of simultaneous translation, consecutive translation and translation of documents for the activities of IPA Floods and Fires programme in Bosnia and Herzegovina.**

**DURATION OF THE CONTRACT:**

Presumably, the activity will start in July 2021 and end in November 2023.

**EVALUATION CRITERIA:**

The evaluation will be based on the criteria of lowest price pursuant to paragraph 4 of Article 95 of Legislative Decree 50/2016 as amended.

**SUBJECT OF THE CONTRACT:**

- A) Simultaneous and/or consecutive translation for online meetings and/or in presence for a maximum of 360 hours.
- In case of online simultaneous translation, the online platform will be made available by CIMA Foundation. The platform is a multichannel one allowing the use of more than one language.
- B) Translation of documents for a total of 200 pages.
- Translation of documents should always be made by native speakers.
  - With one page it is understood a page with 1500 words, including space.



## **MINIMUM ADMISSION REQUIREMENTS:**

Expressions of interest to participate may be submitted by those economic operators referred to in Article 45 of Legislative Decree 50/2016 as amended, who, on the date of the letter of invitation, meet the following requirements:

### **General Requirements**

Requirements provided for by the Directive EC 2014/24/UE with regard to financial and professional obligations (with particular reference to the article 57 of the same Directive) and can, therefore, be awarded contracts by public corporate bodies.

### **Professional Suitability Requirements**

1. Registered in the register of companies of the Chamber of Commerce, Industry, Crafts and Agriculture or in the register of provincial commissions for crafts, or in the competent professional orders pursuant the rules and regulations in the country in which it is resident. Proof of such registration can be either a registration certificate or by means of a sworn declaration or in accordance with the procedures in force in Bosnia and Herzegovina.
2. Having an operative legal office in Bosnia and Herzegovina.

It is understood that the request for expression of interest does not replace any declaration or proof of possession of the requirements for the purpose of awarding the service; the requirements will be requested in the invitation to submit an offer and verified by CIMA Foundation during the tendering process.

Fondazione CIMA reserves the right to discontinue at any time, for reasons within its exclusive competence, the procedure initiated, without the applicants being able to claim any right, including the hypothesis that the number of operators expressing interest does not guarantee effective competition and the possibility of compliance with the principle of cost-effectiveness for the Foundation.

It should be noted that the subsequent procedure will be carried out upon completion of a negotiated procedure, without a call for tenders, pursuant to Article 1, paragraph 2, letter a) of Law 120/2020, with an invitation to the competitors identified as a result of this survey.

A letter of invitation and the documents attached thereto will contain more detailed elements concerning the subsequent course of the procedure, service operating methods and contractual provisions.

Fondazione CIMA will proceed with the sending of the letter of invitation even in case of only one valid expression of interest.
