

# IPA FF Senior expert on Awareness Raising and Sensitization Expression of Interest

#### **Background and context**

CIMA Research Foundation - International Centre on Environmental Monitoring ("CIMA"), an Italian non-profit foundation active in the fields of Civil Protection, Early Warning Systems, Disaster Risk Reduction, Climate Change Adaptation, Marine Ecosystems and Biodiversity Conservation, as part of IPA-FF consortium is looking for a qualified and motivated Senior expert on Awareness Raising and Sensitization initiatives.

The international consortium established by the Italian Civil Protection Department jointly with the Administration of the Republic of Slovenia for Civil Protection and Disaster Relief (URSZR), the Swedish Civil Contingencies Agency (MSB), the Romanian General Inspectorate for Emergency Situations (IGSU), the Fire Rescue Brigade of Moravian-Silesian Region, Czech Republic (FRB-MSR), the National Center for Disaster Management Foundation, Romania (CN APELL-RO) and CIMA Research Foundation, Italy (CIMA) is implementing the 3-years "EU Support to Flood Prevention and Forest Fires Risk Management in the Western Balkans and Turkey – IPA FF" programme under the grant agreement signed with the European Commission Directorate-General for European Civil Protection and Humanitarian Aid Operations (DG ECHO).

More specifically, Within the framework of fostering regional cooperation, exchange of good practices and build skills for life in local communities the IPA FF Programme has planned the initiative "Raising awareness of Forest Fires risk mitigation – IPA FF meets the schools".

The activity is specifically conceived to educate schoolchildren on Forest Fire risk mitigation. The rationale behind the activity is that by educating children, skills for lives get built-in the whole society.

The activity is centred on one contest, open to class groups, based on a common set of support materials to be created and promoted, to gain the engagement of the youth target group. It will also collect and capitalize the locally available sensitization tools, such as audiovisuals, publications, and other deliverables, from different ongoing and already implemented initiatives, executed by the partners independently, and through different donors and implementing agencies at country, regional and sub-regional level.

# 1. Planning the action (8 working days approximately):

- Excellent verbal and written communication skills and capacity to work under pressure and short deadlines.
- Relevant previous experience in the design, execution and reporting of similar activities aiming at sensitization of teenage students on environmental issues, natural risks and related drivers, correct prevention and reaction behaviours.
